- Where:** **Kill Creek Park, 11670 Homestead Lane; Olathe, KS.**

- Time:** 10:30 – 2:00 PM. Lunch will be available at 12:30.
- Activities:** **Off leash area on the beach for the dogs. We will have a life guard, so the lake will be open for swimming.**
- Raffles:** Bring your **check books or cash**
- Shopping:** Silent Auctions
- Bring:** Chairs, dog muzzles and dog collars (mandatory when dogs are off-leash), dog blankets/bed – these pups need a rest, beach towels, and food item for the potluck lunch.
- Food:** Potluck. We will furnish plates, cups, utensils, napkins, and water.
- We would like each person or family to sign up to bring a luncheon item. Lori will send out an email in August to coordinate the food

**Rules:**

- Well-mannered sight hounds
- Dogs must be current on their vaccinations and in good health. Since this is a pretty active event, older or insecure dogs may be happier at home or on a leash.
- Dogs must wear a muzzle and a dog collar with id tags while in the beach off leash area.
- Owners are responsible for cleaning up after their pups.
- Waiver must be signed by all attendees

**T.O.Y.S. Time** (Tiny, older, younger, small and special dogs) - from 11 - 11:15 and 12 - 12:15 we are going to have ONLY the T.O.Y.S dogs on the beach. You will be asked to hold your non-T.O.Y.S. dog during this 15 minute period. This allows those small, young, and special dogs to have the freedom for 15 minutes to romp and also lets our volunteers use the restroom and get a bite to eat.

**Blue Time outs:** For the safety of all the dogs, we have volunteers on the beach to control the activity. For dogs that have high energy levels, we may ask you as the owner to give them a 5 minute "blue" time out, to calm things down. Our goal is to have a safe and fun event for all and we certainly don't want any pet leaving this event with a medical issue.

**Price:**           **\$12.00 per person.** No refunds for no shows.

**\$17.00 per person the day of the event.**

**Directions:** Take I-435 west to I-435 N. Take exit #1B/Lawrence onto Kansas Hwy 10 West, heading toward Lawrence for 10.5 miles. Take exit marked "**Kill Creek**" (just past mile marker 20) and head south or left over the bridge. Drive for 2.8 miles to a "T" in road; turn right or west on **115<sup>th</sup> St** for ½ mile. Then left at next T on **S. Homestead Lane** for 1/3 mile. Enter park **on 117<sup>th</sup> Street**, it is the west side of road. Drive through park, following signs for beach.
