Dogs must be current on their vaccinations  
Dogs must wear a muzzle and dog collar with id while in the beach off leash area.  
Owners are responsible for pooper scooping after their pups.  
Life guard will be available if you want to swim  
Waiver must be signed by all attendees

## Directions for the Park

Take I-435 west to I-435 N. Take exit #1B/Lawrence onto Kansas Hwy 10 West, heading toward Lawrence for 10.5 miles. Take exit marked "**Kill Creek**" (just past mile marker 20) and head south or left over the bridge. Drive for 2.8 miles to a "T" in road; turn right or west on **115<sup>th</sup> St** for ½ mile.
